二、學歷資格/ Academic Qualification Requirements

(一) 申請本專班者需具國外大學理工科系畢業，畢業證書須經官方單位認證。

Applicants for this program should have graduated from a STEM-related undergraduate program. The graduation certificate must be certified by official authorities. (Note: STEM includes Science, Technology, Engineering, and Mathematics)

(二) 申請人畢業學校須為我國教育部認可或當地國政府權責機關或專業評鑑團體認可，符合教育部「大學辦理國外學歷採認辦法」規定之學校，並以教育部駐外館處所推薦國外學校名單之在學生、畢業生為優先。

Applicants must have graduated from schools accredited by the Ministry of Education of the R.O.C. or recognized by local government agencies or professional evaluation organizations, per the 'Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education'. Priority is given to the students who graduate on the list of schools recommended by MOE.

三、語言能力/ Language Proficiency

本校教學以華語授課為主，部分課程採英語授課，申請者需檢附華語文能力證明。

Classes are instructed mainly in Chinese and partially in English. Applicants should provide Chinese proficiency documents.

The statement must be issued by a financial institution within 3 months prior to application OR proof of having a full scholarship or grant provided by a government, university, college, or private organization.

Note 1: Non-personal financial resources must be accompanied by a kinship certificate.

Note 2: If the currency of the bank statement is neither NT dollars nor US dollars, applicants themselves shall do the conversion and write down the exchange rate.

(二)學校獎學金 School Scholarship

1. 第一年學雜費(含教育部補助)之全額補助。

Full subsidy for the first year's tuition and miscellaneous fees (including government subsidies).

2. 學校提供全額校內住宿補助，唯學生需滿足前一學期出席率 90% 以上及操性成績 80 分以上，且無記過以上重大過失違規行為之條件，校內住宿補助至多兩年。(學生每年申請宿舍時需繳納每人 2,000 元新台幣的保證金，作為履行整年宿舍住宿的保證)。Students in INTENSE program will receive a full on-campus accommodation fee subsidy. The requirements for eligibility are as follows: one must have an attendance rate of over 90% and conduct grades above 80 in the previous semester, and not have committed any major infractions resulting in a record of demerits or above. The on-campus accommodation subsidy is available for up to two years. (Students are required to pay dormitory contract bond of NTD\$2,000 per person upon applying for dormitory accommodation annually, as a guarantee for fulfilling a whole year of dormitory residency agreement).

二、生活津貼 Living Allowance Scholarship

合作企業提供生活津貼方式與資格 Methods and Qualifications for Living Allowance Provided by Internship Companies

合作企業提供專班學生第一年就學期間每人每月 1 萬元 生活津貼；第二年實習期間則提供實習崗位與實習津貼 (至少應比照台灣最低基本薪資)。本專班生活津貼由台灣 **日月光半導體製造股份有限公司** 與 **三芳化學工業股份有限公司** 提供。

The cooperative enterprise provides a monthly living allowance of NTD\$10,000 per student during the first year of study. During the second year of internship, the enterprise offers internship opportunities and an internship allowance (no less than the minimal wage NTD\$27,470 per month in Taiwan). The living allowance for this program is provided by **Advanced Semiconductor Engineering, Inc. (ASE GROUP)** and **San Fang Chemical Industry Co., Ltd.**

領取生活津貼學生畢業後即具有留臺就業義務，提供獎助津貼之企業具有優先留用聘僱學生的權利。

After graduation, students are obligated to seek employment in Taiwan. Industries who provide subsidies have the right to prioritize the employment of these students.

Note 1: ASE Inc., with its headquarters in Kaohsiung, Taiwan, has operational bases spanning Mainland China, South Korea, Japan, Malaysia, Singapore, Mexico, the United States, and major cities across Europe. It stands as the world's largest provider of semiconductor packaging and testing manufacturing services.

Note 2: San Fang Chemical Industry Co., Ltd., headquartered in Kaohsiung, Taiwan, has branches in China, Vietnam, and Indonesia. It is one of the global strategic material suppliers for leading sports brands such as NIKE, adidas, and PUMA. Additionally, it is the world's largest manufacturer of synthetic leather for sports shoes.

三、畢業後履行就業義務 Employment Obligation after Graduation

新型專班學生就學期間領取政府及企業獎助，畢業後即具有一定期間的留臺就業義務（不得外派至海外）。學生如中途退出專班或畢業後未履約就業者，所受領之獎助金及生活津貼必須依規定之原則繳還。原則如下：

Students in the INTENSE program receive government and corporate assistance during their study period. After graduation, they are obligated to work in Taiwan for a specified period (without being dispatched overseas). If a student withdraws from the program midway or fails to fulfill the employment obligation after graduation, they must repay the received grants and living allowances according to the specified principles. The principles are as follows:

(一)屬不可歸責於學生之原因，無須繳還獎助金及生活津貼：

If the circumstances are not under student control, there is no requirement for repayment:

1. 原合作企業因營運調整，於學生在學期間停止提供生活津貼，又學生經學校媒合仍無法覓得其他企業願意續予補助生活津貼，致學生中途退出專班者。

Due to the operational adjustment, the original collaborating industry ceases to provide living allowance to student during their learning and student is unable to achieve additional support from other industry, leading the student's withdrawal from the INTENSE program.

2. 原合作企業因營運調整，於學生畢業時無職缺可聘用，又學生經學校進行就業輔導及媒合其他企業仍無法覓得適合企業聘僱者。

Due to the operational adjustment, the original collaborating company has no job vacancies available for employment upon the student's graduation and, and despite the school's efforts in providing career guidance and facilitating job placement, the student is unable to secure suitable employment opportunities.

3. 合作企業於學生就業期間有勞動基準法第十四條第一項規定情形，致學生提出終止契約，又學生經學校進行就業輔導及媒合，仍無法覓得適合企業接續聘僱者。

If the collaborating company, during the student's employment period, encounters situations as specified in Article 14, Paragraph 1 of the Labor Standards Act, leading the student to terminate the contract, and despite the school's efforts in providing career guidance and facilitating job placement, the student is still unable to find a suitable company for subsequent employment.

4. 學生死亡、因重大疾病或意外事故不能繼續就學或就業，經衛生福利部新制醫院評鑑合格之教學醫院以上層級，開立認定無法繼續就學或就業證明者，或因事故致家庭巨變無法繼續就學或就業，經學校查證屬實者。

Student's death, severe illness, or an unforeseen accident preventing them from continuing their studies or employment, a certified document issued by a teaching hospital rated at or above the level of accreditation by the Ministry of Health and Welfare, stating the student's inability to continue education or employment, or in cases where significant family upheaval due to an accident prevents the student from pursuing education or employment, as verified by the school.

(二)屬可歸責於學生之原因，應繳還獎助金及生活津貼：

If the circumstances are under student control, requirement for repayment:

1. 就學期間因個人因素中途退出專班：如申請轉學、轉系、休學返國，經學校輔導後仍放棄繼續就讀專班、或經學校依學則退學、開除學籍等情形。

Withdrawal from the specialized program during the academic period due to personal reasons such as applying for transfer, changing majors, absence, or returning to one's home country. Even after guidance provided by the school, if the student chooses to leave the specialized program or if the school, in accordance with its regulations, initiates withdrawal

or expulsion.

2. 學生學習表現不佳，未通過學校及企業評核標準，並經學校輔導後仍無改善且依學則處以退學、開除學籍等情形。

Poor academic performance, failure to meet the evaluation standards set by both the school and the collaborating industry. Even after school guidance, student fails improve, and in accordance with the school regulations, the student faces withdrawal or expulsion.

3. 學生畢業後選擇不至合作企業或相關產業領域就業，或就業後違反公司規定被依法終止勞動契約，並經學校輔導後仍無改善者。

After graduation, student chooses not to pursue employment with the collaborating industry or in the relevant industrial field, or if, after employment, the student violates company regulations leading to lawful termination of the labor contract, and after school guidance, no improvement is observed.

4. 學生於合作企業就業期間未滿受領獎助金年限：應依其未就業之月數比例繳還產學獎助金；不滿一月者，以一月計。

If a student, during the employment period with the collaborating industry, does not complete the specified duration for receiving scholarship, repayment should be made based on the proportion of the remaining months unemployed; for periods less than one month, one month's repayment is required.

- 一、本校外國學生之入學申請，由各系（所）依其訂定之入學標準進行初審，招生委員會就初審通過名冊予以複審，審查合格錄取之外國新生名冊報請校長核定後，由國際暨兩岸事務處發給錄取生錄取通知。

The admission of international students will first be evaluated by each corresponding department according to their own admission criteria. A preliminary admission list will be compiled and submitted to the Admission Committee for further review. A final admission roster will be submitted to the principal for approval. An Admission Letter will then be sent to each admitted student by the Office of International and Cross-Strait Affairs.

- 二、錄取生收到錄取通知後，應於規定時間內回覆國際暨兩岸事務處入學本校之意願。
Applicants who received the Admission Letter should confirm his/her enrollment to the Office of International and Cross-Strait Affairs before the deadline stated.

- 三、本校確認錄取生有入學意願後，即由國際暨兩岸事務處將入學許可以電子郵件方式及紙本方式寄送給新生。

Once the enrollment is confirmed, Admission Certificate will be sent to all admitted new students by e-mail and hard copy.

- 四、外國學生入學申請之結果，原則於本校國際暨兩岸事務處受理申請後 3 個工作天內通知申請人（假日順延）；申請人如於交件 7 個工作天後，未接獲本校通知者，請逕洽本校國際暨兩岸事務處查詢。

Application should be processed within 3 working days starting from the day the application is received. If applicants receive no messages from the school after 7 working days, please do not hesitate to contact us immediately.

捌、報到與註冊入學/ Registration and Admission

- 一、外國學生接到入學許可後，應依規定程序辦理報到及註冊手續，逾期未辦理報到者，即以自動放棄入學資格論，但事前以書面提出延期申請並經許可者，不在此限。

Once students receive the Admission Certificate, enrollment procedures should be taken following the provisions of the procedure. Students who fail to enroll on time will be deemed to forfeit their rights of admission, except a written petition is submitted for extension approval.

- 二、外國學生經入學後，如發現有申請文件資格不符、偽造、假借、塗改等情事，一經查明即開除學籍，亦不發給任何學歷證件；如於畢業後始發覺者，除勒令繳銷其畢業證書外，並公告取消其畢業資格。

Admission shall be denied and/or the student shall be dismissed from Fooyin University after admission if there are any violations of the general academic honor codes and/ or in the authenticity of the applicant's documents. Those who have graduated shall have their diploma revoked.

- 三、外國學生接獲本校入學許可後，須提出接獲錄取通知後3個月內之健康檢查記錄。

Upon receiving Admission Certificate, all students need to provide a Health Examination Form with certificate dated within the past 3 months.

- 四、外國學生來臺註冊後，仍需配合參加本校新生體檢。

Each student also needs to have a physical examination in school after registration.

輔英科技大學新型專班學生重要權利義務通知書

Notice of Rights and Obligations for students

1. 依教育部辦法規範申請來臺就讀本專班，以一次為限。於完成申請就學學校學程後，除申請碩士班以上學程，得逕依各校規定辦理外，如繼續在臺就學者，其入學方式應與我國內一般學生相同。

Application for studying in Taiwan is based on terms and regulations from Ministry of Education, limited to one-time only. After submitting application (except for master degrees or above), please follow regulations from each school. Also admission process should be exactly the same as local Taiwanese students.

2. 學生成績分學業、操行兩種，以一百分為滿分、六十分為及格，成績不及格或不通過之科目，不給予學分。

Grades will be measured by academic and conduct, 100 as full score and 60 below as fail. Credits will not be given for subjects failed.

3. 大學部修業年限為 4 年，若未在修業年限內完成者，以退學論。

Maximum study period is 4 years for undergraduate. Students will be drop out if not able to complete the degree within 4 years.

4. 學生需於學校規定時間內繳交學雜費與其他費用，若未依規定時間繳交者，將依逾期未註冊理由，處以退學。

Tuition and other fees must be paid during the semester. Students will be drop out if not able to pay in time.

5. 因學生使用學生簽證入學，若有休學、退學，必需於 10 天內離境。被退學之學生，將失去申請台灣各大學學士以下級別之使用外國學生身分入學之資格。若休學後復學，需重新辦理居留簽證與換發居留證。

Students must leave Taiwan within 10 days after graduation drop-out of school or dismissal by oneself. For dismissal students who will not be able to apply for any undergraduate (or below) degree in Taiwan as an international student. For reinstatements after approval to leave, students must re-apply and renew their Alien Residence Certificate.

6. 學校提供全額校內住宿補助，唯學生需滿足前一學期出席率 90% 以上及操性成績 80 分以上，且無記過以上重大過失違規行為之條件，校內住宿補助至多兩年。

Students in this program will receive a full on-campus accommodation fee subsidy. The requirements for eligibility are as follows: one must have an attendance rate of over 90% and conduct grades above 80 in the previous semester, and not have committed any major infractions resulting in a record of demerits or above. The on-campus accommodation subsidy is available for up to two years.

7. 專班學生在學期間兩年皆依規定住校；自第二學期起若有特殊情況，得提出申請並通過審核得免住宿。

Students in the program are required to reside in on-campus dormitories for the entire two-year study period; however, starting from the second semester, those with special circumstances may apply for exemption from this requirement, which may be granted upon approval.

8. 請假:需提前完成學校(在校上課期間)或實習廠商(實習期間)之程序，如無特殊事由且未完成者以曠課論。

Leaves: students must complete all study or internship courses in advance, otherwise will be considered as absence.

9. 學生於考試時如有作弊行為，一經查出，除該次成績以零分計算外，並視情節輕重分別予以記過、勒令退學或開除學籍之處分。

If cheating is found during a test, the grade will be counted as 0. Also, students may get demerited or even drop out and expelled, depending on the situation.

10. 學生入學後可申請工作證，無校外工作證或違反政府規定工讀時數(學期間工讀時數每週最多 20 小時，寒暑假期間工讀時數每週最多 40 小時)，經學校或任何單位查獲者，將有罰款並有立即遣返回國之可能性。

Students can apply for a work permit after enrollment. Without valid working permit or any students who against working hours regulation (maximum 20 hours per week during semester, maximum 40 hours per week during winter/summer vacation), the student may be fined or even be expelled/deported back to one's country of origin.

11. 考量專班係為客製化專班及課程銜接相關事宜，該專班之學生不得任意轉換學校，轉系則依學校相關規定作。

International Industry-Academic Cooperative Program for the New Southbound Students is designed to combined the academic and corporation operations with specialized courses, therefore, students in this program are not allowed to transfer to any departments or colleges at school.

12. 欲轉換為至一般外國學生身分，需符合一般外國學生入學申請相關規定，並需回國自行重新辦理簽證，於申請成功後之下個學期起轉換身分。學校將發給入學或轉換身分通知書，並依規定重編年級與班級。

Transfer to general international student: Students must be qualified by Regulations of International Student Admission, and go back to one's country of origin to re-apply VISA, then transfer to new role from next semester. The school will issue a new admission letter or role-transfer notice, also re-arrange grade and class accordingly.

13. 辦理復學之學生，需於規定時間內向學校申請復學、自行重新辦理簽證。學校依符合當學期開設所屬系所之產學專班缺額給予復學，若無專班名額，學生得以轉換為一般外國學生身分入學一般學士班。

Handling of Reinstatement: students must submit application for reinstatement in time and re-apply VISA by oneself. Then school will arrange for reinstatement according to the vacancy from this Program in the department. In cases there are no available quotas in this program, students may be admitted as regular foreign students in the Four-Year Bachelor Program.

14. 依教育部規範，學生須於一年級第二學期結束前通過華語文能力測驗(TOCFL) B1(含)以上，如未通過華語文能力 B1 級(含)以上測驗者，將會無法獲得獎助學金。

According to the regulations of the Ministry of Education, students must pass at least TOCFL Level 3 (B1) before the end of the second semester of the first year. If students fail to achieve a level of B1 or above on the TOCFL, students will not be eligible for scholarship.

15. 實習課程將會由學生、學校與廠商訂定三方合約書，其中將明訂權利與義務。

A contract will be signed by student, school and employer for internship courses, all rights and obligations will be defined inside the contract.

16. 產學合作專班為三方(學生、學校、廠商)合作之專案，為達到課程學分要求，學生需配合學校與廠商所安排的實習課程內容與時間規畫。

Industry-Academic Collaborative Program is designed for three parties (students, school and employers). To meet the requirements to obtain full credit, students must comply with content of the internship courses and time management schedule promulgated by the University and the Employer.

17. 學校校區內一律禁菸禁酒。違規者並依學校規定辦理。(依政府禁菸防治法規定違規者得罰鍰新台幣 2,000 - 50,000 元)

Smoking and any alcoholic practices are strictly prohibited inside the campus. Anyone who violates the rules intentionally will be fined between NTD\$2,000 and NTD\$50,000.

18. 居留證每年需延長一次費用為 1,000 元，有效期限需自行注意，國際事務中心將協辦新辦或延期。

Residence permit must be extended every year with cost NTD\$1,000. Please check the valid date yourself. International Affair Center will assist to apply or extend.
