Except the dissemination, promotion and assist international students in necessary procedures to Taiwan, The recruitment of international students at Providence University is not permitted to commission any external institution, legal person, group, or individual to handle related matters.

### 六、申請資格 Applicant's Eligibility

1. 申請資格依據教育部「外國學生來台就學辦法」、「僑生回國就學及輔導辦法」及本校「靜 宜大學外國學生入學招生規定」為基準。

Applicant's eligibility is based on the Ministry of Education "Regulations Regarding International Students Undertaking Studies in Taiwan", "Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan" and "Providence University Admissions Regulations for International Students".

### [外國學生身分資格 International Students' qualification]

2. 具外國國籍且未曾具有中華民國國籍(\*註1),(1)未曾以僑生身分在臺就學、(2)未於當學年度 經海外聯合招生委員會分發,得申請入學。

A person of foreign nationality who has never acquired the R.O.C. nationality (\*1), has never studied in Taiwan as an overseas Chinese student, and has not accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year may apply for admission.

3. 具外國國籍且符合下列規定,於申請時並已連續居留(\*註2)海外六年以上者(\*註3),得申請入學。

A person of foreign nationality who has resided overseas (\*2) continuously for at least 6 years (\*3) at the time of application and satisfies the following requirements may apply for admission.

- (1). 申請時兼具中華民國國籍,應自始未曾在臺設有戶籍。
  A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan since birth;
- (2). 申請前曾兼具中華民國國籍,於申請時已不具中華民國籍者,應自內政部許可喪失中華 民國國籍之日起至申請時已滿八年。

A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least 8 year before making their application; and

- (3). 前2款未曾以僑生身分在臺就學,且未於當學年度經海外聯合招生委員會分發。
  A person who have never studied in Taiwan as an overseas Chinese student nor accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year.
- 4. 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外連續居留(\*註2)六年以上者,得申請入學。

A person of foreign nationality, who is eligible for permanent residence in Hong Kong or Macau, who has never held household registration in Taiwan since birth, and, who at the time of their application has resided in Hong Kong, Macau or elsewhere overseas (\*2) continuously for at least 6 years may apply for admission.

5. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外(\*註2)六年以上 者,得申請入學。

A person who was formerly from the Mainland Area who has foreign nationality and has never held household registration in Taiwan since birth, and who at the time of their application has resided

- overseas (\*2) continuously for at least 6 years may apply for admission.
- 6. 依教育合作協議,由外國政府、機構或學校遴薦來臺就學之外國國民,其自始未曾在臺設有 戶籍者,經教育部核准,得申請入學。
  - A foreign national who was selected by a foreign government, organization or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never held household registration in Taiwan since birth may apply for admission with prior consent from the Ministry of Education, R.O.C.
- 7. 在臺就讀其他大學校院時,未因操行或學業成績不及格、違反法令或校規情節嚴重致遭退學 或喪失學籍者。
  - An international student is not permitted to re-apply for studying in Taiwan if he/she has been expelled from an educational institution in Taiwan or had his/her student status forfeited due to unsatisfactory conduct or academic performance or a serious violation of any ordinances or the regulations of the educational institution.
- 8. 外國學生具國外高中畢業資格者或具有與我國學制相當之同等學力資格者,得申請入學本校學士班;具學士學位者或具有與我國學制相當之同等學力資格者,得申請入學本校博士班;具碩士學位者或具有與我國學制相當之同等學力資格者,得申請入學本校博士班。 An international student with a foreign high school graduation certificate or equivalent qualifications to those of the R.O.C. academic degree system may apply for admission to a bachelor's degree program at Providence University; a bachelor's degree or equivalent qualifications for a master's program; and a master's degree or equivalent qualifications for a PhD program.
- 外國學生申請入學本校學歷採認,除依我國「外國學生來臺就學辦法」規定辦理,並應符合 以下規定:
  - The assessment and recognition of foreign academic credentials should be subject to the MOE Regulations Regarding International Students Undertaking Studies in Taiwan as well as the following rules:
  - (1). 持大陸地區學歷:應依我國「大陸地區學歷採認辦法規定辦理」。
    Academic credentials from the Mainland Area: The MOE Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area should apply.
  - (2). 持香港或澳門學歷:應依我國「香港澳門學歷檢覈及採認辦法規定」辦理。
    Academic credentials from Hong Kong or Macau: The MOE Regulations Governing the Examination and Recognition of Educational Records from Hong Kong and Macao should apply.
  - (3). 持同等學力申請入學者,其同等學力認定標準應符合我國教育部公告之「入學大學同等學力認定標準」。
    - The assessment and recognition of academic credentials at an adequate level of education should be conducted in accordance with the MOE Standards for Standards for Recognition of Equivalent Educational Levels for University Admission.
- 10. 國外高中或大學以上學歷文件須符合我國教育部採認之學校。請參考我國教育部兩岸教育司網頁查詢:請至我國教育部網頁→點選「國際及兩岸教育」→點選「業務專區」→點選「海外留學」→點選「外國大學校院參考名冊」。

The foreign high school, college, or university where an applicant earned his/her graduation certificate, diploma, or academic credentials should be officially recognized by the Ministry of Education, R.O.C. Please visit the Database for the Reference List of Foreign Universities for more details.

11. 如違反上述任一條件之申請者,經查證屬實後,撤銷入學資格、開除學籍或本校畢業資格,且不發給任何學歷證明。

An applicant who is found to have violated any of the aforesaid rules should be disqualified from admission or have his/her student status forfeited, or the degree diploma issued should be revoked. Providence University reserves the right to not issue any certificate to such a student.

### [僑生身分資格 Overseas Chinese Students' qualification]

12. 僑生:海外出生連續居留迄今,或最近連續居留海外6年以上,並取得僑居地永久或長期居留證件回國就學之華裔學生。

The term "Overseas Chinese student" refers to a student of Chinese descent who has come to Taiwan to study, who was born and lived overseas until the present time, or who has been living overseas for six or more consecutive years in the immediate past and obtained permanent or long-term residency status overseas.

13. 僑生經輔導來臺就學後,在臺停留未滿二年,因故退學或喪失學籍者,得重新申請來臺就學, 並以一次為限,但僑生經入學學校以操性或學業成績不及格、違反法令或校規情節嚴重致遭 退學或喪失學籍者,不得依本項規定申請入學。

An overseas Chinese student who received assistance to be assigned to an educational institution in Taiwan who studied for less than two years because for some reason they discontinued their studies or forfeited their student status may lodge another application to come to Taiwan to study, but only one such re-application is permitted.

However, if the educational institution in Taiwan where the overseas Chinese student was studying considers that the student's conduct or academic performance was unsatisfactory, or if the student violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of the regulations governing student awards and penalties, the student had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan based on the provisions of this paragraph.

14. 凡有下列情形之一者,不得依本簡章之規定申請來臺升學,違反規定者,取消錄取資格;已 入學者,應令退學並撤銷學籍。

Anyone falling under the following circumstances is not allowed to apply for study in Taiwan according to the provisions of this regulation. Violators will have their admission qualifications revoked; those already enrolled shall be expelled and have their student status revoked.

- (1). 曾在臺肄(畢)業之高中學生。
  - High school students who have graduated in Taiwan.
- (2). 持偽造或冒用、變造證明文件或護照者。

Those holding forged, counterfeit, or altered certification documents or passports.

- (3). 已申請喪失中華民國國籍經核准有案且尚未取得他國國籍者。
  - Those who have applied for loss of Republic of China nationality, approved but have not yet obtained foreign nationality.
- (4). 分發錄取後身分不符合規定者。

Those whose status does not match the requirements after being admitted through allocation.

(5). 曾以外國學生身分申請來臺就學錄取並就讀者。

Those who have previously applied for admission to Taiwan as foreign students and have enrolled.

### \*註1:依「中華民國國籍法」第二條規定,有下列各款情形之一者,屬中華民國國籍:

- \*1: Pursuant to Article 2 of the R.O.C. Nationality Act, a person should have the nationality of the Republic of China under any of the conditions provided by the following subparagraphs:
  - (1) 出生時父或母為中華民國國民。

His/her father or mother was a national of the Republic of China when he/she was born.

- (2) 出生於父或母死亡後,其父或母死亡時為中華民國國民。
- He/she was born after the death of his/her father or mother, and his/her father or mother was a national of the Republic of China at the time of death.
- (3) 出生於中華民國領域,父母均無可考,或均無國籍者。

He/she was born in the territory of the Republic of China, and his/her parents can't be ascertained or both were stateless persons.

(4) 歸化者

He/she has undergone the nationalization process.

- \*註2:海外係指大陸地區、香港及澳門以外之國家或地區;所稱連續居留,指外國學生每曆年在國內停留期間不得逾120日。
- \*2: The term "overseas" refers to countries or regions other than the Mainland Area, Hong Kong, and Macau. The term "an uninterrupted period of residence" means that an individual should have stayed in Taiwan for no more than a total of 120 days in each calendar year.
- \*註3:六年、八年,以擬入學當學期起始日期(2月1日或8月1日)為終日計算之。
- \*3: The period of six years or eight years mentioned above should be calculated by using the start date of the semester (February 1 or August 1) in which an applicant wishes to enroll as the end date of the period.

4. 推薦書兩份。

推薦書需說明申請者之學術潛力、參與課外活動的情形、個人品格、英文及中文語言能力以及是否具有獨自國外求學的能力。推薦信須以中文或英文撰寫。

Two letters of recommendation which address the applicant's academic potential, participation inextracurricular activities, personal character, level of English and Chinese proficiencies and a comment regarding whether the applicant is mature enough to study abroad.

The letters should bewritten either in English or in Chinese.

5. 讀書計畫乙份,請以中文書寫。(申請英文授課系所學程之學生必須以英文書寫讀書計畫)

A Study Plan written in Chinese.

(Applying for English-taught programs, the study plan should be written in English.)

6. 三個月內的財力證明。由銀行提供並證明申請者足夠支付在臺灣生活、保險、書籍及其他 大學相關費用之財力證明。財力證明須申請者本人帳戶且不得少於美金3,300元 (新台幣 100,000)。若財力證明非申請者本人,則須附上經濟資助信。

Financial statement within 3 months to prove the applicants can support his/her living expenses, insurance fee, books, and other university related fees. The financial statement must include account holder's name and validate a current balance of at least USD 3,300 (NTD. 100,000). If the financial statement is not in the name of the applicant, an Affidavit of Support must be included.

7. 填具外國學生獎助學金申請表(線上申請後由系統自動產出)。

Fill in and sign the International Student Providence Grant Application Form (Print this from the online system after completing the online application.)

8. 護照或其他證明國籍的文件影本。

A photocopy of the applicant's passport or other equivalent supporting documents.

9. 護照規格相片。

The passport-sized photograph.

10. 曾具中華民國國籍之外國人士必須檢附已不具中華民國國籍之證明文件,應自內政部許可放棄後,至申請時已滿8年。

A foreign national citizen who was formerly a citizen of the Republic of China must attach a certificate indicating that he/she is no longer a legal citizen of the Republic of China (Taiwan), and has already given up his/her Taiwan citizenship for 8 years or above.

11. 申請轉學者必須附上目前學校的在學證明及成績單。

Applicants applying as a transfer student must submit the official certificate of enrollment and transcripts from his/her current university.

12. | 語言測驗檢定證明 Language Proficiency Certification

#### (1).申請全英文授課系所:

申請者全英文授課學系(碩士班)需繳交相當於CEFR B2 (含)以上如托福TOEFL ITP 550或雅思IELTS 6.0或多益TOEIC 700以上或等同之國際英語認證考試,或經本校審查認定英語能力達上述標準者。

For applying for the Master degree program of fully English taught programs, applicants need to submit an official English proficiency certificate which is equivalent to CEFR B2 level; TOEFL ITP 550, IELTS 6.0, TOEIC 700 or equivalent certificate or those whose English proficiency has been qualified by the school.

- 國籍為英語系國家者可免繳,請提供護照作為證明。
   Students who are from countries use English as the Official or Common Language,
   please prove by submitting your passport
- 在英語系國家取得前一學位者可免繳,請提供畢業證書作為證明。
  Applicants get the diploma in a country where English is the Official or Common Language, please prove by submitting the graduation diploma.
- 畢業於英語授課之學校者可免繳,請出具學校之英語授課證明。
   Applicants graduated from a school where English is the language of instruction and a certificate issued from school should be submit.
- ※ 申請入學英文授課班級者,入學第2年華語文能力測驗(TOCFL)須達基礎級(Level 2,相當於CEFRA2);聽、讀2項皆須達A2 級(含)以上)。

Students are required to **pass A2 level of TOCFL** (A2 level of Listening and Reading) in the  $2^{nd}$  year of the study.

For those failing to complete the credits, courses, and degree thesis for a master degree or a dissertation for a doctorate or meet other criteria for graduation, the regulations on the extension of study period are as follows:

### 一、 新型專班之產學獎助金 Industry-Academic Scholarship for the INTENSE Program

- 1. 新型專班之產學獎助金來源包括行政院國家發展基金及合作企業,包含:
  The funding for the Industry-Academic Scholarship includes National Development Fund of
  Executive Yuan and the collaborative enterprises:
  - (1) 學生初次來台的必要行政費用(檢附收據核銷,上限新台幣1萬元):來臺前的健康檢查費用、簽證費用及文書驗證費用,由行政院國家發展基金提供。

Necessary administrative expenses for students' first arrival in Taiwan (receipt attached for the reimbursement, with a maximum of NTD. 10,000): The fees are sponsored by the National Development Fund of Executive Yuan, including Health examination fees prior to arrival in Taiwan, Visa fees, and documents verification fee.

(2) **來臺單程機票**:由行政院國家發展基金提供,以直航之經濟艙單程機票,上限為新台幣 9,000元。

**One-way flight to Taiwan**: Provided by the National Development Fund of the Executive Yuan, with a maximum limit of NT\$9,000 for an economy class one-way ticket on direct flights.

  "Providence University Student Grant/Scholarship" again.
- 2. 學生於就學期間領取政府及企業獎助,畢業後即具有一定期間的留臺就業義務,與領取企業生活津貼期程相同;即領取企業 2 年生活津貼者,必須於該企業工作義務 2 年。

  Students receiving the government and enterprise scholarships during their studies are obligated to work in Taiwan for a certain period after graduation. For instance, those receiving a 2-year living allowance from the industry are obligated to work for a period of 2 years.
- 3. 產學獎助金繳還原則:

Industry-academia scholarship repayment principles:

(1) 就學期間因個人因素中途退出專班,如申請轉學、轉系、休學返國,經學校輔導後仍放 棄繼續就讀專班、或經學校依學則退學、開除學籍等情形,學生應全額返還已領之產學 獎助金。 If a student withdraws from the INTENSE program due to personal reasons during their studies, such as transferring to another school, changing majors, taking a leave of absence to return home, and after counseling from the school still decides not to continue the program or is expelled from the school according to the regulations, the student shall fully repay the received industry-academia scholarship.

- (2) 學生學習表現不佳,未通過學校及企業評核標準,並經學校輔導後仍無改善且依學則處 以退學、開除學籍等情形,學生應全額返還已領之產學獎助金。
  - If a student performs poorly academically, fails to meet the assessment standards of the school and enterprises, and after counseling from the school shows no improvement and is subsequently expelled from the school according to the regulations, the student shall fully repay the received industry-academia scholarship.
- (3) 學生畢業後選擇不至合作企業或相關產業領域就業,並經學校輔導後仍無改善者,學生 應全額返還已領之產學獎助金。
  - If a student chooses not to work in a cooperating enterprise or related industry sector after graduation, and after counseling from the school shows no improvement, the student shall fully repay the received industry-academia scholarship.
- (4) 學生畢業就業後違反公司規定被依法終止勞動契約,並經學校輔導後仍無改善者,學生 應依未就業之月數比例返還產學獎助金;不滿一月者,以一月計。
  - If a student violates company regulations and has their employment contract terminated legally after graduation, and after counseling from the school shows no improvement, the student shall repay the industry-academia scholarship proportionally based on the number of months not employed; if less than one month, it shall be counted as one month.
- (5) 學生於合作企業就業期間未滿受領產學獎助金年限:應依其未就業之月數比例返還產學 獎助金;不滿一月者,以一月計。
  - If a student does not work for the cooperating enterprise for the entire period covered by the industry-academia scholarship: the student shall repay the industry-academia scholarship proportionally based on the number of months not employed; if less than one month, it shall be counted as one month.

- 第一條 本招生規定依教育部「外國學生來臺就學辦法」、「專科以上學校維護外國學 生受教權益應行注意事項」及本校學則暨相關規定訂定之。
- Article 1 This admission regulation is formulated in accordance with the Ministry of Education's "Regulations Regarding International Students Undertaking Studies in Taiwan", "Guidelines for Higher Education Institutions in Taiwan on Safeguarding the Rights and Interests of International Students", and the regulations and related provisions of our university.
- 第二條 具外國國籍且未曾具有中華民國國籍,符合下列規定者,得依本招生規定申請 入學:
- Article 2 A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission in accordance with the provisions of these regulations:
  - 一、未曾以僑生身<u>分</u>在臺就學。 Applicant has never undertaken studies in Taiwan as an overseas Chinese student.
  - 二、未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會 分發。

Applicant has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous paragraph.

- 第五條 辨理外國學生招生業務,除宣傳推廣及協助學生辦理來臺相關必要程序外,不 得委由校外機構、法人、團體或個人辦理,並於招生網站宣示上開未委外辦理 之相關事項。
- Article 5 Handling the admission affairs for foreign students, aside from promoting and assisting students in completing necessary procedures for coming to Taiwan, shall not be outsourced to external organizations, legal entities, groups, or individuals. It must be explicitly stated on the admissions website that no outsourcing is conducted for related matters.

Our university's promotion of enrollment for international students is carried out through our university's website, the Study in Taiwan webpage, overseas alumni organizations, and participation in overseas physical or online educational expos. There is no delegation to external agents for promotion and enrollment.

- 第六條 本校外國學生招生簡章詳列招生方式、入學資格審查程序、招生學系(程)、各學系(程)授課語言、學生應具備之語文能力基準、修業年限、招生名額、申請資格、財力證明基準、學雜費收退費基準、本校獎助學金資訊及其他相關事項。
- Article 6 The brochure for the admission of international students in our university provides comprehensive information on the admission procedures, eligibility review process, offered programs, languages of instruction for each program, language proficiency requirements, duration of study, enrollment quotas, application qualifications, financial proof standards, tuition and fee refund policies, details about scholarships offered by the university, and other relevant matters.
- 第七條 外國學生申請入本校就學,應依外國學生入學招生簡章所定之時程,檢附下列 文件向本校國際暨兩岸事務處申請,初審通過後送交申請系所進行審查。各系 所審查通過名單,經本校招生委員會通過後,發給入學許可:
- Article 7 International students applying for admission to our university shall submit the following documents and apply directly to the university during its designated application period, and applicants who passed the review or screening process will be issued an admission notice:

  - 二、學歷證明文件(含成績單。中、英文以外之語文,應附中文或英文譯本): Academic credentials (including the transcript. For documents which are not in either Chinese or English languages, a translated of either Chinese or English is required):

    - (二) 香港或澳門學歷:應依香港澳門學歷檢覈及採認辦法規定辦理。 Academic credentials from Hong Kong or Macao: shall be handled in accordance with the provisions of the Regulations Governing the Examination and Recognition of Educational Qualifications from Hong Kong and Macao.

Academic credentials from other areas:

- 1. 海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。 Academic credentials issued by an Overseas Taiwan School or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan.

However, academic credentials issued by a campus or branch that a foreign educational institution has established in the Mainland Area by a foreign educational institution shall be notarized by a notary public there and authenticated by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan.

Other documents required by the relevant department being applied to. 外國學生已在臺完成學士以上學位,繼續申請碩士以上學程者,得檢具我國各校院畢業證書及歷年成績證明文件,不受第一項第二款規定限制。

An international student who has completed a bachelor's degree or a higher degree in Taiwan and is applying to be admitted to do a master's degree program or a higher degree may submit copies of their graduation certificate from a university or tertiary college in Taiwan and transcripts for each year of their studies and apply in accordance with the provisions of Article 7 and is not subject to the provisions of Article 7, Paragraph 1, subparagraph 2.

外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部(班)或私立高級中等學校外國課程部班畢業者,得持該等學校畢業證書及歷年成績證明文件依規定申請入學,不受第四條第一項及本條款第一項第二款規定限制。

An international student who has graduated from a school for international residents in Taiwan, or from a bilingual division (program) affiliated to a domestic senior secondary school, or from a program offering a foreign curriculum at a division of a domestic private senior secondary school may submit copies of their graduation certificate, and their transcripts for each year, and apply for admission in accordance with the provisions of Article 7 and is not subject to the provisions of Article 7, Paragraph 1, subparagraph 2.

However, upon enrollment, applicants are required to submit a document certifying the highest academic qualification (in languages other than Chinese or English, a translation in Chinese or English should be attached) from the foreign school that has been verified by the foreign organization in the country.

When an educational institution reviews an international student's admission application, if any of the documents specified in Subparagraphs 2 and 6 of the preceding paragraph have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the educational institution has any doubts about them, it may request authentication by an overseas agency If documents that have already been authenticated raise any doubts, the educational institution may request examination of the documents.

The admission notice shall set out in detail in both Chinese and English the name of the international student, the name of their program of study, the degree level, the language of instruction, the academic year of enrollment, the date the semester begins, the tuition and miscellaneous fee collection and refund criteria, any scholarship or grant awarded to the student, and any other pertinent information that international students must be notified of, and verify that international students studying in Taiwan understand their associated rights and obligations. University may provide versions of these details in other mother languages of its international students.

- 第八條 除國際專修部、新南向國際產學合作專班及招生法令另有規定之班別外,本校 招生學系(程)依授課語言及申請學生應具備之語文能力基準分為以下:
- Article 8 Except for the International Foundation Program, International Programs of Industry-Academia Collaboration in Taiwan and others classes under the relevant regulations, the standard of the language proficiency for the admission departments and the requirement for the applicant are as listed below:
  - 一、申請中文授課之學系(程)者,其華語文能力測驗(TOCFL)應達 A2(含)級以 上或相當等級之國際通用中文能力證明。
    - For applicants who is applying for the Chinese-taught program, one should meet the requirement of TOCFL level A2 or others International Chinese proficiency certificate.
  - 二、申請全英文或部分英文授課,且可滿足畢業要求之學系(程),其英語文能力測驗應達 CEFR B1(含)級以上。
    - For applicants who is applying for the English-taught program, one should meet the requirement of CEFR level B1 or others equivalent official English proficiency certificate.

- Article 9 A university that admits international students shall promptly register details of the following into the international student data management information system designated by the Ministry of Education: the international students admitted and registered, any transfer, deferral or abandonment of studies, and any change to or loss of student status.

- Article 10 In principle, the actual number of places available for international students to be admitted to universities and two-year programs at junior colleges (hereunder referred to as "universities and tertiary colleges") is limited to an additional ten percent above the admission quota that was approved for the institution for the previous academic year by the Ministry of Education, and that number shall be incorporated into the total admission quota and reported to the Ministry of Education for approval. A university or junior college applying to recruit more than an additional ten percent shall submit a report of the planned increment (including associated quality control strategy and supportive measures) to the Ministry of Education for approval. Degree programs offered by collaborating domestic and foreign universities that have been approved on a case-by-case basis by the Ministry of Education are not subject to this restriction.

  Article 11 An international student is not permitted to apply to study any recurrent or
- An international student is not permitted to apply to study any recurrent or continuing education bachelor's degree program or in-service master's degree program, or any other program which is only taught in the evening or during vacations, at a university or tertiary college in Taiwan. However, an international student who already has legitimate resident status or who is undertaking a program approved on a case-by-case basis by the Ministry of Education is not subject to this restriction.
- 第十二條 外國學生註冊入學時,未逾該學年第一學期修業期間三分之一者,於當學期入學,已逾該學年第一學期修業期間三分之一者,於第二學期或下一學年註冊入學。但教育部另有規定者,不在此限。
- Article 12 An international student who reports to register at a university or tertiary college, a

five-year program at a junior college, or a senior secondary school, junior high school, or an elementary school before it is already one-third of the way into the first semester of the current academic year shall be registered for the first semester. If it is already more than one-third of the way into the first semester, the international student shall register for the second semester or the next academic year. However, this restriction does not apply if each competent education administrative authority has some provision that overrides it.

- Article 13 Our university may sign an education cooperation agreement with a foreign educational institution and recruit and admit international exchange students, provided that this does not affect normal teaching. A university or tertiary college may also apply, mutatis mutandis, its own international student admission regulations to accept suitable international students as non-degree students. With approval from each competent education administrative authority, senior secondary schools, junior high schools, and elementary schools may recruit international students for short-term periods of study in Taiwan of one year or less.
- 第十四條 本校得因國際學術合作計畫或其他特殊需求須成立外國學生專班者,應依專科 以上學校總量發展規模與資源條件標準相關規定,經教育部核定。
- Article 14 If the university is required to set up a special class for foreign students due to international academic cooperation programs or other special needs, it should be approved by the Ministry of Education in accordance with the relevant regulations on the total development scale and resource conditions of post-secondary schools.
- 第十五條 外國學生得依教育部有關獎學金相關規定及本校相關獎勵辦法,申請各種獎助 學金。
- Article 15 In order to provide incentive awards for outstanding international students who are studying at universities and tertiary colleges in Taiwan, the Ministry of Education may set up international student scholarships or may subsidize universities to do so, university may allocate funds to set up scholarships or financial study assistance to international students.
- 第十六條 外國學生保留入學資格、轉學、轉系、休學、退學及其他學籍、學業、生活輔 導考核等事項,悉依本校學則及有關法令規定辦理。
- Article 16 Foreign students' retention of enrollment status, transferring to another school or department, suspending or withdrawing from school, as well as other matters related to school registration, academics, and life-counseling assessments, will be handled in accordance with the school's Academic Regulations and relevant laws and regulations.

An international student who with Ministry of Education approval is undertaking an internship after graduating from a university in Taiwan may have their international student status extended for up to one year after their graduation.

- 第十七條 外國學生來臺就學後,其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、 歸化或回復中華民國國籍者,喪失外國學生身分,應予退學。但入學方式與我 國內一般學生相同者,及依國籍法第四條第一項第一款至第三款申請歸化取得 中華民國國籍者,不在此限。
- Article 17 An international student who has been permitted to undertake initial household

registration, resident registration, naturalization, or restoration of R.O.C. nationality procedures during the course of their studies in Taiwan will forfeit their international student status and shall be dismissed by their educational institution. However, student whose application was handled in the same manner as the admission procedures for domestic students and who apply for naturalization to acquire the nationality of the ROC in accordance with Subparagraph 1 to 3, Paragraph 1, Article 4 of the Nationality Act is not subject to this requirement.

- 第十八條 就讀我國大專校院之外國學生,得經本校外國學生申請方式轉學進入本校就 讀。但外國學生經原就讀學校以操行不及格或因刑事案件經判刑確定致遭退學 者,不得轉學進入本校就讀。
- Article 18 If international student who studies in university in Taiwan want to transfer to another university. Each university shall formulate its own regulations regarding transfers of international students who study in university in Taiwan, incorporate these into its admission regulations, and submit these to the Ministry of Education for approval. However, an international student who has been dismissed by the educational institution that admitted the student as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to transfer to another university.
- 第十九條 本校外國學生就學應繳之費用,依下列規定辦理:
- Article 19 The tuition related fees that international students in Taiwan shall pay are determined as stipulated below:
  - 一、經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及具我國永久居留 身<u>分</u>者,依本校所定之本地生收費基準。

Students who have been admitted to study in Taiwan in accordance with the provisions of the previous two articles, or who have received a MOFA Taiwan Scholarship following recommendation by an overseas mission, or who have the status of permanent residents in Taiwan shall pay tuition and other fees in accordance with the standard fees that their educational institution applies to domestic students.

- 二、依教育合作協議入學者,依協議規定辦理。
  Students admitted to an educational institution in Taiwan in accordance with an education cooperation agreement shall pay their tuition and other fees as specified in the agreement.
- 三、前二款以外之外國學生,依本校訂定收費基準,並不得低於同級私立學校 收費基準。

If an international student is not covered by the provisions of either of the preceding two subparagraphs, an educational institution may charge the student based on the standard tuition and other fees for international students that it has determined, and these are not permitted to be lower than the fees levied by other private educational institutions at the same level.

Foreign student who was admitted to an educational institution in Taiwan before the date of effect of the February 1, 2011 amendment to these Regulations shall pay tuition and other for this stage of education fees in accordance with the preamendment provisions.

第二十條 外國學生有違反就業服務法之規定經查證屬實者,本校應即依規定處理。

- Article 20 If an investigation verifies that an international student has violated the provisions of the Employment Services Act, their educational institution, or the appropriate competent authority shall immediately handle the matter in accordance with the regulations.
- 第二十一條 本校外國學生就學申請、獎助學金申請、輔導、聯繫等事務由國際暨兩岸事務 處與本校相關單位負責辦理,並於每學年度不定期辦理相關輔導活動或促進校 園國際化,有助我國學生與外國學生交流、互動之活動。
- Article 21 University shall designate units or personnel to be responsible for handling international student admission applications, counselling, and liaison matters. At different times each academic year, the university shall organize counselling activities for international students or promote campus internationalization in help to foster exchanges and interactions between local students and international students.
- 第二十二條 外國學生於本校附設華語文教學中心學習華語文者,其入學辦法依本校華語文 教學中心規定辦理。
- Article 22 International students who intend to study in the Chinese Language Education Center (CLEC) in Providence University (PU) should follow the regulations of the PU CLEC for the application.
- 第二十三條 外國學生如有休學、退學或變更、喪失學生身分等情事,應通報外交部領事事 務局及本校所在地之內政部移民署服務站,並副知教育部。
- Article 23 If an international student defers or abandons their studies, or if there is any change or loss of their student status, PU must notify the Bureau of Consular Affairs of the Ministry of the Foreign Affairs, the service center(s) of the National Immigration Agency and notify the Ministry of Education.
- 第二十四條 外國學生註冊時,新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險,在校生應檢附我國全民健康保險等相關保險證明文件。
- When an international student registers, student shall submit proof of being covered by a medical and injury insurance policy which is valid for at least six months from the date that they entered Taiwan. Current students shall present documentary proof that they have joined Taiwan's National Health Insurance Plan. 前項保險證明如為國外所核發者,應經駐外機構驗證。
  If the proof of insurance referred to in the previous paragraph was issued in a foreign country, it shall be authenticated by an overseas mission.
- 第二十五條 外國學生所繳入學證明文件有偽造、假借、塗改等情事,應撤銷錄取資格;已 註冊入學者,撤銷其學籍,且不發給任何相關學業證明;如畢業後始發現者, 由本校撤銷其畢業資格並註銷其學位證書。
- Article 25 If the submitted documents for the application by the student was found to be forged, fabricated, or it has been altered in some way shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student will be cancelled and will not be awarded any certification whatsoever regarding their related academic undertakings. If any such circumstances are discovered after a student has already graduated, PU will revoke the former student's eligibility to graduate and shall require any degree already awarded to be returned and to be rescind.
- 第二十六條 本招生規定未盡事宜,依教育部「外國學生來臺就學辦法」、「專科以上學校 維護外國學生受教權益應行注意事項」及本校學則與相關規定辦理之。
- Article 26 Acts that have not been covered in these enrollment regulations shall be handled in accordance with the Ministry of Education's "Regulations Regarding International

Students Undertaking Studies in Taiwan", "Guidelines for Higher Education Institutions in Taiwan on Safeguarding the Rights and Interests of International Students" and the regulations and related provisions of our university.

第二十七條 本招生規定經招生委員會議通過,報請教育部核定後施行,修正時亦同。
Article 27 These regulations have been submitted to the Enrollment Committee and are approved by the Ministry of Education. Any amend will gone through the same manner.
